一、质量方针 Quality Policy

二、管理承诺 Management Commitment

厦门广信隆技术服务有限公司（AL-BAQARA CERTIFICATION，以下简称“ABC”），系依法注册的独立法人实体，具备独立开展 HALAL 认证的法定资格与能力。为确保认证客观、公正、权威，ABC 郑重承诺：

Xiamen Guangxinlong Technical Service Co., Ltd. (AL-BAQARA CERTIFICATION, hereinafter referred to as "ABC") is a legally registered independent legal entity with the statutory qualification and capability to independently conduct HALAL certification. To ensure the objectivity, impartiality and authority of certification, ABC solemnly makes the following commitments:

2. 公正性与利益回避 Impartiality and Conflict of Interest Avoidance

回避制度，确保判断客观。

ABC maintains absolute neutrality. It adheres to objectivity and impartiality throughout the certification process, eliminates commercial bribery, improper interests and external interference, and ensures the credibility of certification. Where any certification personnel have an interest relationship with a client, the avoidance system shall be strictly implemented to ensure objective judgment.

3. 独立性承诺 Independence Commitment

ABC 坚持独立法人、独立运营、独立承担法律责任，实行独立核算、自收自支，认证经费来源于合法服务收费，不接受任何影响公正性的捐赠、资助或利益输送。

ABC adheres to being an independent legal entity with independent operation and independent assumption of legal liability. It practices independent accounting and self-financing. Certification funds are derived from legitimate service fees. ABC does not accept any donations, grants or interest transfers that may compromise impartiality.

ABC strictly protects clients' trade secrets and technical information, and will not disclose undisclosed information to third parties without authorization.

5. 非歧视性承诺 Non-Discrimination Commitment

Treat all customers equally with unified standards, fair processes and objective results without discrimination.

6. 资源保障承诺 Resource Assurance Commitment

配备充足人员、设施、技术与财务资源，保障认证规范、高效开展。

Provide sufficient personnel, facilities, technical and financial resources to ensure standardized and efficient certification.

7. 宗教合规承诺 Religious Compliance Commitment

ABC 为穆斯林所有的独立实体，严格遵循伊斯兰教法（Shariah），确保审核员及决策委员会均为穆斯林并具备相应宗教知识与公正立场，杜绝违背清真原则的行为。
